- 15 % Fail on People

- 95 % of 1700 1750 Juniors Fail

Evaluating Junior Resource Companies: Share Structure, People, & Projects

- Three Key Criteria : 5 % Pass = 80 90
- Final Test: Undervalued with Peers
- 20 % of 80 90 Undervalued
- 15 20 Stocks on My Radar Screen

The Power of Two

- Speculating and Trading Philosophy
- Pick Undervalued Stock
- Doubles in 12 Months or Less
- Sell ¹/₂ of Position
- Cost Basis = Zero for $\frac{1}{2}$ of Position



The Power of Two

- Playing with Someone Else's Money
- Reinvest Money in a New Undervalued Stock
- Open Orders to Sell ¹/₂ at Double
- Programmed Selling at Intervals on Uptick
- Programmed Selling at Intervals on Downtick
